III. Election of Directors

IV. Guest Speaker - Jim Donahue, Aquatic Weed Control

Handout on main lake treatment areas was distributed. The state chooses where we are allowed to treat weeds. We are limited to treat only 10% about 75 to 80 acres. Sechrist and Kuhn lakes are considered cold water lakes because of the water clarity and cannot be treated for weeds, except for the entrance of Sechrist. All channels can be treated because channels are considered man made. The approved areas on the lakes were sprayed for weeds on 5/9/17 and all of the channels were treated on 6/8/17. Areas were treated for algae on 6/23/17 and 6/27/17. Discussion on treating the east end of Sechrist. Neil and Jim agreed to look into getting an amendment to treat the area. No starry stone wart yet. The invasive weed is on Webster, Tippecanoe, and Syracuse lakes.

Lon Sloan made a motion to close the Board of Directors Meeting, Steve Dillman Seconded. Motion Carried.

Balance of \$118,000. Ron Miller made a motion to approve the Treasurer's Report. Lon Sloan Seconded. Treasurer's Report approved.

- a) <u>Weeds</u>: Neil Schwartz Received several emails from people on Sechrist Lake expressing concern about the weed situation. The number of people paying in to weed control is down considerably.
- <u>Buoys and Signs:</u> Bill Thompson Received a donation from winner of the flotilla for the amount of \$150 and purchased a ramp for the hot dog boat. Because of the high water and other weather conditions did not get the signs in this year.

- f) <u>Grassy Creek Watershed Foundation</u>: Paula Stinson Balance of \$7,475.16 as of June 7. Transfer from BLPOA of \$13,000 to GCWF. Paid some weed bills. Balance as of meeting, \$492.66. Expecting a LARE refund of \$3,206.94.
